Landlords cannot impose late fees unless the rule or policy is clear and accepted by the tenant when the landlord and tenant enter into the tenancy agreement. A late fee is lawful as long as it is a reasonable pre-estimate of damages and not a penalty.

Three of the notice forms are for a landlord to use to tell a tenant that the rent for their rental unit will increase. N10 is used when a landlord and tenant agree to increase the rent by more than the rent guideline.
